

# United Task Force Member Contract

1. I understand that upon approval of this document I will be accepting 'membership' in an organization referred to as the "United Task Force". The UTF is a non-profit club dedicated to recreational pursuits as a cohesive unit that openly participates in the modern combat sport referred to as "airsoft".
2. I understand that my membership relies upon my continued adherence to the UTF charter. I have read and understand the charter knowing that items within the charter may be added, deleted, or altered during the course of my participation. I understand that my participation within the UTF is also bound by the airsoft rules of play and that I am also bound by international, federal, state, and local laws.  
In signing this document, I agree to adhere to the charter and any subsequent releases.
3. I understand that my membership within the UTF entitles me various benefits and/or rights under the UTF charter. Upon using the various benefits and/or rights, I understand that I am expected to volunteer my efforts in order to assist other members in achieving the goals, objectives, and requirements of the organization.

#### 4. **Non-Disclosure and Confidentiality Agreement**

I understand that my membership may constitute and contain valuable proprietary products and trade secrets of the UTF, embodying substantial creative efforts and information, ideas, and expressions. I understand that I must treat sensitive information as confidential and may not disclose to non-members. I also understand that this agreement will extend beyond my termination or resignation from the UTF.

I understand that unauthorized use, transfer or disclosure of any sensitive information may (I) substantially diminish the value to the UTF of the trade secrets and other proprietary interests; (II) render UTF's remedy at law for such unauthorized use, disclosure or transfer inadequate; and (III) cause irreparable injury in a short period of time.

If the confidentiality of sensitive information is breached, the United Task Force shall be entitled to equitable relief to protect its interests therein, including, but not limited to, preliminary and permanent injunctive relief.

#### 5. **Loaned Equipment Policy**

I understand that I am personally responsible for any item acquired, assembled, or otherwise loaned to me by the UTF and that is subject to forfeiture upon my termination or resignation.

I understand that only UTF members are to use group property, and that the UTF may seek compensation for items that are loaned to me but otherwise used by non-members.

I understand that I am responsible for maintaining the upkeep of any item acquired, assembled, or otherwise loaned to me by the UTF. I understand that the UTF may retrieve fair compensation for any items damaged or not returned due to loss or theft. Exceptions for 'normal wear and tear' may apply, but does not include damages from misuse, abuse, neglect, or lack of common sense when using loaned equipment.

#### 6. **Insignia and Device Policy**

I understand that upon approval of this document I may use insignias, devices, symbols, styles (brand, identification, trademark, etc) unique to the UTF, and that it is subject to forfeiture upon my termination or resignation.
